On my behalf and on behalf of the Board of Management I welcome you for the new academic year.

Am pleased to report that we are ready for the Junior Secondary School. We have constructed the physical infrastructure consisting of a brand new Administration block that will herald 13 new classrooms, 2 well-equipped modern laboratories for the technical subjects, 2 offices and ablution facilities for staff and students. We have also put in place the necessary teaching personnel as required. As result of this increased capacity, an in light of the changes made by the Ministry of Education regarding the management of Junior Secondary School and due to increased demand, we have increased our class streams from 3 to 4 for each class. The extra classes are almost ready together with the attendant facilities. As earlier advised we also acquired a bus for this JSS section.

We also bring to the attention of the members that the Club is refurbishing the garage and erecting a shade for parking our buses in order to protect them from the vagaries of Coastal weather, which exposes them to quick decay and rust. Consequently, there is a level of interference with the parking space, which will remain until the civil works are completed. Kindly bear with the situation.
